Personal Code of Conduct:

I would like to be able to say that I am honest in all that I do, but that would itself be a statement of dishonesty on my part. The truth is that I have been dishonest in that past. I have lied to my parents at times in order to minimize any potential punishment for my bad behavior. I have lied to my friends at times in order to get out of lending my friends money or going to a party. I have lied to telemarketers who ask to speak to my parents that they are not at home, even though they were sitting right in front of me at the time. I am not a completely honest person because I have apparently found, as an indication of my reactions in certain circumstances, that it is not always practical to be honest 100% of the time in life. But these reactions that have resulted in consequences that have only affected me... and, of course, my parents, friends, and random telemarketers. The truth is that I can be dishonest at times when it is convenient to be so. I call it "convenient dishonesty".

My future practice of law will be focused around helping and advising clients – real people with real problems who will rely on me to resolve issues that they could not resolve themselves. This is the exact reason that I am working to obtain my law degree and be a "minister of justice", as they call it. The reality is that in order to uphold the integrity of the legal profession, each individual member of the profession must uphold the integrity in himself or herself. This means that each legal professional must be honest in all that he or she does. Each lawyer must act with integrity at all times, especially at times when it is difficult to do so because that is when it counts the most. Each of us must be honest enough without ourselves in order to know our individual professional strengths, weaknesses, and limitations.

I hope to soon become a member of the legal profession. Honestly, my convenient dishonesty is an improper character trait, and what is worse is that it is in my control. Lawyers undoubtedly on a day-to-day basis are faced with situations where convenient dishonesty could lead them on the path to least resistance and make their lives incredibly easier. Convenient dishonesty is a tempting choice. But this choice can affect not only their integrity and reputation, but it will also adversely affect the integrity of their clients. This is not the kind of lawyer that I want to be. I want to be the legal professional that upholds integrity in herself, thereby upholding the integrity of the legal profession. I don't want to be conveniently dishonest anymore. A client could never trust or respect someone who is dishonest. I want my clients to trust and respect me. I want to protect my clients, and I want to do so openly, sincerely, and with the utmost integrity.

The Laws of Coduct to be followed by

All the standards of professional conduct, whether contained in Acts of Congress or in practice rules (written or unwritten) which are binding upon lawyers in Unites States of America are based upon certain values and principles which form the foundation of the profession and reflect the legal, moral and professional obligations of the lawyer to:

- 1. the clients;
- 2. the courts and other authorities before whom a lawyer pleads his client's cause or acts on his behalf:
- 3. the public; and
- 4. the legal profession in general and each fellow member of it in particular.1

And Carlo will also follow:

- 5. A lawyer must always act with intregrity and always looks our for their client's interest and will not misrepresent a client, or, through inaction, allow a client to be misrepresented.
- 6. A lawyer must obey the wishes given by clients, except where such wishes would conflict with the above.
- 7. A laywer must act with values, such as honesty, responsibility, loyalty and respect for everyon in order to ensure a successful and fruitful career as an advocate for those who need a need a voice when there is a void of Justice.²
